The minutes from the Mar 28th business meeting were approved as read.

Membership/Admissions/Initiations: Patrick Petrick has been approved to take 1st Degree.

Grand Knight's Report:

- Bill Remy was elected Knight of the Quarter for his outstanding support of the state raffle, multiple council events and his sharing of the Knights of Christ books from the Colorado KofC Charities Fund.

- The GK asked about the status of the Fr. Seamus scholarship selections. Speaking for the selection committee, Paul Doran reported receipt of 2 applications from the St. Joseph Catholic School and 13 applications from the Cathedral Parish School. Paul will inform the GK when the selection meeting is scheduled.
- Net total from the St. Patrick's brunch was \$4628. The GK proposed preparation of a large ceremonial check for this amount to be presented to the pastor at an upcoming 8:00 a.m. mass to help pay down the mortgage for the St. Enda of Aran Faith Formation Center. The members agreed.
- Concerning the Tootsie Roll drive, we were not able to secure a week at Winn-Dixie this year so were only able to collect about half of what is normally collected, i.e. \$3279.97. Subtracting \$748.70 in expenses netted \$2834.43. Of this amount, \$734.43 will be allocated to the Special Olympics of St. Johns County and \$700 each will be allotted to the ARC of St. Johns County, Haven Horse Ranch and KofC American Wheelchair. In addition, the Fish Fry team will donate \$500 to Camps I Am Special Care and Promise.

FINANCIAL AND COMMITTEE REPORTS:

Treasurer's Report: An internal audit was successfully conducted and a revised Treasurer's Report was provided for the month of March 2019. As of April 26th, the Fr. Seamus Scholarship Fund balance was \$13,128.36, which includes a transfer from the council general fund of \$3564.67. The general fund began the month with a balance of \$13,812.46; income was \$267.84 and expenses were \$362.25, leaving a balance of \$13,718.05. Copies of the March and April Treasurer's reported are enclosed.

SERVICE PROGRAMS and COMMITTEES:

The April meeting netted \$50 income from a basket raffle; the May meeting will feature a 50/50 raffle. Br. Tom noted that these events are great opportunities for family members to participate with the Knights and to meet prospective members, so please get the word out and encourage greater participation. Fred Hernandez has agreed to sponsor the June social meeting; would be good to get other sponsors as well.

- The GK received a call from the diocesan representative for the Respect Life Ministry. They plan to use the Celebration Hall on October 11-12 and will have three bishops in attendance. Although no specific request for help was made, we may get a request in the future.
- Bill Remy reported that potential dates for the Fall Festival/Oktoberfest are September 14, 21 and 28 and October 5. The pastor will be consulted for his preference. He also announced that he would be handing out hand-made rosaries to the recent confirmands on April 29th; fellow Knights are welcome to join.
- Steve Barthelmes announced that the Fish Fry Team would like to donate \$1500 to the collection for seminarians with the proviso that the \$300 state rebate be contributed in the memory of Rusty Dirlam. The members agreed.

FOURTH DEGREE: Faithful Navigator John Alexander reported that Matt King, son of ex-manager of local Publix and fellow Knight, Chris King, will be ordained as a priest on the first Sunday of May. John also reported that Councils 7121 and 11046 and Assembly 166 contributed to the advertisement in the "St. Augustine Record," explaining why the Knights would not participate in the local Easter Parade held on Holy Saturday.
